INTERNAL RULES

1° - Opening of the campsite:

From APRIL 12 to OCTOBER 12, 2024

Opening the barrier (entry/exit)

**From 9 a.m. to 9 p.m.
In April , May, June, September and October .**

From 8:00 a.m. to 10:30 p.m. in July and August.

2° - Reception:

**Open from 9:00 a.m. to 12:00 p.m. AND 2:00 p.m. to 7:00 p.m. (out of season).
9:00 a.m. to 12:00 p.m. AND 2:00 p.m. to 8:00 p.m. (July /August)**

3° - Admission conditions:

To be allowed to enter or settle in a campsite, you must have been authorized by the person in charge of the reception office and pay your residence or visitor rights. No one can take up residence there. Staying on the Lac de la Seigneurie campsite implies acceptance of the provisions of these regulations and the commitment to comply with them.

Any infraction may result in the expulsion of the perpetrator with recourse to the police if necessary.

It is prohibited for any vehicle to travel before 8:00 a.m., except in emergency cases.

4° - Police formalities:

Minors unaccompanied by their parents will only be admitted with written authorization from their parents.

In application of [article R. 611-35](#) of the code of entry and stay of foreigners and the right of asylum, the manager is required to have the client of foreign nationality complete and sign, upon arrival, a individual police form. It must mention in particular:

- 1° The surname and first names; 2° The date and place of birth;
- 3° Nationality;
- 4° The usual residence. Children under the age of 15 may appear on the file of one of the parents.



The campsite management is responsible for the order and good maintenance of the campsite. It has the duty to sanction serious breaches of the regulations and, if necessary, to expel their perpetrators.

5° - Installation:

The tent, camper van or caravan and all equipment must be installed in the location indicated by management.
Campers can only change location with the prior agreement of management.

6° - Royalties:

Fees (tourist tax if applicable, overnight stays and supplements) are to be paid at the reception desk upon check-in. Their amount is fixed in the prices. They are due according to the number of nights spent on the site.

Camp users are invited to notify the reception office of their departure the day before, it cannot be before 8:00 a.m.

Campers must leave before 12 p.m. otherwise an additional day will be charged.

7° - Seasonal residents/sedentary workers:

A year-round rental contract for a location intended for the installation of an RML is signed annually by sedentary residents. It governs the relationship between the manager and the tenant.

8° - Noises:

Camp users are urged to avoid any daytime or nighttime noise pollution that could disturb other campers. Sound devices should be adjusted accordingly.
During the high season, the campsite can organize festive evenings which close at 11:30 p.m. at the latest.

9° - Visitors:

Daily visitors are allowed to enter for a fee which they must pay at reception, where they must present themselves, before entering the campsite.

Visitors admitted to the campsite are the responsibility of the campers who receive them. **They are not allowed to use the swimming pool**. The vehicle must be parked in the parking lot.

Visitors must report to reception and comply with the internal regulations.

They will have to leave the campsite before the gates close, or pay for a night like a camper. No more visitors will be tolerated after the campsite barriers are closed.

VISITORS TIMES:

10:00 a.m. to 8:00 p.m.

10:00 a.m. to 10:00 p.m. in JULY AND AUGUST

RATE :

3 € / per person (from 3 years old)

€3 per animal (upon presentation of up-to-date vaccination record)

10° - Circulation and parking of vehicles:

Inside the camp, vehicles must travel at a speed limited to **10 km/h.**



When parked, vehicles must remain in their location and not obstruct traffic or prevent the installation of new arrivals.

The number and type of vehicle authorized is 1 (one) per location .

Visitor cars are not allowed in the campsite. They must park at the entrance to the camp in the parking lot.

An exemption will be issued for people with reduced mobility with the agreement of management.

From 9 p.m. (or 10:30 p.m. in July and August) to 8 a.m., the circulation of any vehicle is prohibited inside the camp. Except in cases of proven emergency

Electric vehicles :

IT IS STRICTLY PROHIBITED TO CHARGE YOUR ELECTRIC VEHICLE IN HOUSING OR ON EXTERNAL ELECTRICAL TERMINALS

The electrical installations of our mobile homes and electrical terminals allocated to the pitches are not suitable for charging electric vehicles. Therefore, it is strictly prohibited to connect an electric or hybrid vehicle to the electrical installations of the mobile home . In the event of violation of this provision, the customer will be held responsible for any material or immaterial damage (short circuit, fire, etc.) caused by the connection, vis-à-vis the campsite and/or third parties.

Violators will be expelled without refund. A charging station is available at an additional cost (ask at reception)

11° - Animals:

Pets are, subject to reservation, allowed on the campsite.

They must be tattooed and vaccinated, presentation of the vaccination record is required.

Dogs are strictly prohibited inside certain rentals, in the bathrooms, snack bar, swimming pool

Dogs will be **kept on a leash** throughout the campsite.

1st and 2nd category dogs will not be accepted. Any dangerous animal will be refused on the campsite by management.

Animal owners must ensure that they do not bother other campers and that they do not dirty the campsite or the infrastructure. Excrement must be collected.

It is forbidden to leave them unsupervised or locked in vehicles or rentals on the campsite.

12° - Children and Games :

Children are accompanied and under the responsibility of parents in the play areas.

It is strictly forbidden to throw stones. It is strictly forbidden to climb on the fence surrounding the swimming pool

The toilets are not a place to play, you don't run there, you don't play with water or paper, you don't slam doors.

Children are accompanied by an adult to the toilets and showers, the latter ensures that the premises are clean after use.

No violent or disturbing games can be organized near the facilities. In play areas, children are the responsibility of their parents.

The ball games will take place on the plateau, behind the swimming pool.

A loan of rackets , table football or Ping Pong balls or other is organized. The equipment must be collected and returned at reception or at the bar.



13° - Maintenance and appearance of the installations:

Everyone is required to refrain from any action that could harm the cleanliness, hygiene and appearance of the camp.

It is prohibited to throw polluted water onto the ground or into rainwater gutters.

“Caravanners” must empty their waste water in the facilities provided for this purpose (chemical WC emptying outside the toilets).

Washing is strictly prohibited outside of the bins provided for this purpose.

Laundry will be hung in the common dryer. However, it will be tolerated, near shelters, on the condition that it is very discreet and does not disturb the neighbors .

It should never be made from trees

SELECTIVE SORTING :

Household waste (food, diapers, paper towels, coffee capsules, pizza boxes, etc.) must be placed in a closed bag in the gray bins at the entrance to the campsite.

The campsite is engaged in an active selective sorting process . For this purpose, a specific bin (yellow lid) accommodates plastic, packaging, metal and paper. They will be thrown away in bulk, not in a trash bag.

A bin for glass is also available at the entrance to the campsite.

A composter is intended to receive organic waste (follow the instructions indicated on site)

It is strictly forbidden to deposit any non-household waste. It is the campers' responsibility to take all non-household waste to the Etueffont recycling center.

Plantings and floral decorations must be respected.

Campers are prohibited from driving nails into trees and cutting branches.

It is not permitted to demarcate the location by personal means, nor to dig the ground.

It is prohibited to install any structure on the rented location. Any illegal installation will result in the expulsion of the camper.

Any achievement other than the installation of a caravan or awning must be the subject of a written request addressed to the campsite management.

No work, installation or planting can be carried out without the written agreement of management

Any damage to vegetation, fences, ground or camp facilities will be the responsibility of the perpetrator.

Cleaning cars, caravans and campers is prohibited on the campsite.

A washing area is available at Leclerc Masevaux (5 km).

14° - Security:

Fire :

Open fires on the ground (wood, coal, etc.) are strictly prohibited. Stoves must be maintained in good working order.

Fire extinguishers are available to everyone. In the event of a fire, immediately notify management.



A first aid kit is available at the reception desk.

Weather report :

All locations must be free of objects that could be dangerous during weather events. The swimming pool is closed in the event of a weather alert and activities canceled for safety reasons.

Flight :

Management is only responsible for items left in the office. Report immediately to management the presence or behavior in the camp of any suspicious person.

Camp users are invited to take the usual precautions to safeguard their material possessions.

15° - General respect:

In addition to the specific provisions which define the activities and use of the campsite, campers are required to respect other users.

In general, any behavior that disturbs other campers is prohibited.

Activities that cause disturbing emissions (noise, bad odors, smoke, etc.) or pose a danger to the installations and layout are not permitted.

All campers are required to comply with the provisions of the internal regulations.

Anyone staying at the campsite must be registered at reception.

The management reserves the right to evict definitively and without notice or reimbursement, people who do not respect the internal regulations, or who have not declared all the occupants or have given false information concerning the occupants of the plot or of rental. Staying in the campsite implies that campers accept the terms of these regulations.
